The Quotationer should quote rate for different categories of vehicle against the stage given below including fuel & others charges i.e. loading & unloading of stacking of materials at the destination. Charges may be claimed for one side from loading point to unloading point.

The payment will be made for actual distance covered from loading point to unloading point only and no payment will be made against any down word or back journey if not instructed before.No demurrage will be allowed for detention on the road for any circumstances.The decision of the department will be final in case of dispute if any for ascertaining of any distance from spot to spot covered.

Each & every bill should be submitted to this office along with challan and distance & place of transport should also be certified by the concern officers with full signature and designation with official seal.Otherwise no challan will be entertained.

Accepted rate will be ordinary valid for one year from the date of acceptance/contract which may be further extended or reduced at the discretion of the undersigned.Work order will be issued as and when required within the valid period of tender.The selected agency will have to place vehicles at loading point at the schedule time and date as per work order with in a notice of 24 hours communicated over telephone or written.
