Sealed Tender is invited in plain paper by the undersigned from the Bonafied Suppliers/Tenderers for supply of well decomposed Cow dung Manure which should free from any alteration like mud, straw, other materials etc. Sealed Tenders to be superscribed on the outer surface of envelop **RE-TENDER FOR COWDUNG MANURE [2nd Call]**. Incomplete Tender in any respect will not be accepted.

Tentative requirement of Cow dung Manure for different Sericultural Nurseries/Farms of this district are as follows.

The rate is to be quoted per 100 (one hundred) CFT including Transportation charges with loading and unloading charges and all other incidental charges up to the Unit site of the above mentioned Farms as per instruction of the concerned Unit Officer. **12.5% will be deducted as void** from the gross volume measured and rate to be quoted against net volume.

The Tender must be accompanied with photo copy of current I.T, PAN & GST No. Earnest Money must be deposited @ 5% of the total amount of quoted value by a demand DRAFT in favour of **“DEPUTY DIRECTOR OF TEXTILES (SERICULTURE), MALDA”**. The earnest money submitted earlier would not be entertained in a fresh tender. **Tendarer who has submitted tender with required EMD against the 1st call vide Tender Notice No. 686 dated 09.08.2017 may submit tender with same EMD and need not deposit EMD further if not withdrawn.**

The Tender will be received by this office through Registered Post/Speed Post only up to **02.00 P.M. on 22.09.2017** and will be opened on the same day at **02.30 P.M.** in presence of members of the Tender Committee and Tenderers or their authorized agent if any remain present.

Acceptance of the lowest or any other Tender is not obligatory. The undersigned reserves the right to accept or reject any or more or all Tenders without assigning any reasons and take no responsibility of Tender received after the last date and time. Quantity may vary according to the availability of Fund and changing requirement of the farm/other unavoidable circumstances at the time of procurement.

The Tender once accepted will be valid up to 31st March, 2018.

The successful Tenderer will be required to stack the materials on flat surface at the site of the inspection at each unit and supply will have to be completed within 30 (Thirty) days from the date of issue of the work /supply order. Work order will be issued and payment will be made subject to the availability of Fund received from Govt.

Measurement of quantity & assessment of quality will be made by a measurement committee to be constituted from this end and materials will be accepted subject to satisfaction of the committee.
