Sealed tenders are invited by the Asstt. Director of Sericulture, Dakshin Dinajpur, Balurghat in plain paper from intending suppliers for purchase of well decomposed Cow Dung Manure for under mentioned units. The manure must be free from all adulteration like ash, mud, straw etc. 12.5% void will be deducted from the gross quantity of supply (For the F.Year-2021-22).

Rate should be quoted per cft which include loading, unloading, transportation and other incidental charges up to the supply point.

The tender must accompany an earnest money for Rs. 5000/- (Rupees Five thousand) only in the form of Demand Draft from any nationalized bank in favour of "Assistant Director of Textiles (Sericulture), Dakshin Dinajpur, Balurghat". The tender must be accompanied by current income tax clearance certificate attaching photocopy of PAN Card. Envelope containing tender would be super scribed with "Tender for Cow Dung Manure". 
